- State Trade Expansion Program (STEP)
- State Small Business Credit Initiative (SSBCI)
- Technical Assistance for SSBCI Clients
- Collaboration/Partnership with Department of Lands & Natural Resources
- Collaboration with International Economic Development Organization (IEDC)

STATE SMALL BUSINESS CREDIT INITIATIVE

- Originally established in 2010, and later reauthorized by the American Rescue Plan Act (ARPA) of 2021
- A combined \$10B to states, tribal governments, territories, the District of Columbia (DC)
- Provides funding for credit and investment programs for existing small businesses and start-ups
- \$57M allocated to the CNMI; estimated time to deployment is Dec 2022

SSBCI TECHNICAL ASSISTANCE

- Technical assistance to small businesses applying for SSBCI funding
- Provides help with legal, accounting, and financial services to SSBCI borrowers



The CNMI State Trade Expansion Program (STEP) is a state-federal partnership funded in part through a grant with the U.S. Small Business Administration to eligible CNMI small businesses new to exporting or market expansion. STEP is designed to support participation in allowable activities including: foreign trade missions, trade shows, export training workshops, design of marketing media, website fees, product labeling/packaging, and export-related subscription services.

The STEP program is a 2-year grant with a goal of recruiting and helping eligible small business concerns (ESBCs) to participate in the program. Such assistance includes website development/translation services, product packaging/labeling, business matchmaking and attendance to a foreign trade show. Eligible applicants must have a current business license and must be a US Citizen/Permanent Resident.
